Minutes of the 'Committee on Compassionate Engagement (CCE) Meeting' held on 06-01-2022 to consider the cases of engagement in GDS cadre on compassionate ground

The 'Committee on Compassionate Engagement (CCE)' met on 06-01-2022 to consider the cases of engagement to GDS posts on compassionate ground. Following officers were present in the CCE as constituted vide CO Memo No. Rectt/CRC/(PA/SA, PM/MG, MTS)/2019 & 2020 dated 21.09.2021:

- 1) Sri J.Lalrinsailova, PMG, North Bengal Region - Chairman.
- 2) MsNeetu, Director of Postal Services, Headquarter - Member.
- 3) Sri Ashoke Pal, DPS, South Bengal Region -Member.

2. Total 27 cases were placed before the CCE for consideration out of which 21 cases have been recommended and the list is placed at **Annexure A**. 3 cases have been considered but not recommended due to found over-aged i.e above 40 years and the list is placed at **Annexure B**. 1 case has been considered but not recommended due to lack of minimum educational qualification i.e. below 10th standard and the list is placed at **Annexure C**. 1 case has been considered but not recommended due to submission of educational qualification certificate issued by a non recognized board of secondary education and the list is placed at **Annexure D**. Remaining 1 case has been considered but not recommended as the applicant is married daughter and not dependent on the deceased GDS on the date of his death and the list is placed at **Annexure E**.

3. In view of the above, 21 cases as mentioned in **Annexure A** were considered by the Committee and recommended.
