In this regard, you are requested to kindly give wide publicity through various mode like issuing circulars, notice, Departmental web-site etc. regarding conducting of LDCE-2022 to all the eligible employees working in all the units under your jurisdiction. A copy of Recruitment Rules (RR) of AAO as published in Gazette of India dated 2<sup>nd</sup> April, 2018&DoP's Examination Notification vide No. 3-37/2022-PACE, dated 15.02.2022 containing all instructions/syllabus etc. are enclosed herewith for wide circulation. The applications from the eligible candidates in prescribed application Form in Annexure-A & B (application form is available with Exam Notification dated 15.02.2022) may be received only up to 8<sup>th</sup> March, 2022 for applicants other than Army Postal Services & on Deputation out of DoP/DoT and up to 15<sup>th</sup> March, 2022 for applicants of Army Postal Services & on Deputation out of DoP/DoT in A4 size paper. The candidates are advised to refer to Instructions for filling up Application Form as per Annexure-C of Examination Notification dated 15.02.2022. The acknowledgement receipt has to be provided by the Head of Divisions / Units to each applicant other than Army Postal Services & on Deputation out of DoP/DoT and the applicants who are on Deputation out of DoT/DoP or are on Deputation to Army Postal Services, the acknowledgement of receipt of application Form shall be issued by State Nodal Officer (SNO). The applications received after last date of submission as mentioned ibid and also if they do not fulfill the conditions will be rejected summarily.
