I have been directed by the competent authority to publish the departmental Examination for promotion of LGOs to PA/SA cadre in respect of LGO Exam. held on 09.12.2018 against the vacancies pertaining to the year 2016-17, 2017-18 & 2018(from 01.04.2018 to 31.12.2018) (Departmental Quota). The allotment order of qualified candidates of the LGO Exam for appointment as PA/SA on merit and allotted to Division/Unit according to vacancies available therein in enclosed.

2. List of qualified candidate(s) and list of Surplus candidates on merit in respect of each RMS Division/Unit is enclosed. RMS Division/Unit heads are requested to verify the current status of the qualified candidates before declaration of the allotment order at their end. If it is found later that any of those candidates were not eligible to appear in the said examination under rules or instruction or for other reasons, his/her name will be deleted.
3. The name of the candidates have been arranged in order of merit, Division/Unit wise according to year wise no. of vacancies available in the Division/Unit under Departmental Quota. The seniority will be determined according to the principle laid down in the Dte. communication no. 27-24/65-NCC dtd. 07.04.1966.
4. Result of 02(two) candidates permitted provisionally to appear in the above mentioned examination is kept in sealed cover and the result will not be declared without regularization of their provisionality/till final disposal of the relevant cases. The SSPos, South Hooghly Division is should intimate the status of the provisionality of the concerned candidates.
5. The selected SC/ST candidates should be asked to produce the original certificate for detailed scrutiny by the Head of Division/Unit to see the following:-
  - i. SC/ST certificate is issued by the appropriate authority and in prescribed form.
  - ii. It is genuine and complete in all respect.
 All these actions must be completed before joining of the candidates as PA/SA. The Divisional/unit heads are requested to cause timely issuance of appointment letters so that

the officials can join in their respective offices of posting at the earliest not later than 28.02.2019. The guidelines issued by the Directorate vide letter no. 60-11/2011-SPB-I dated 16.09.2011 may be taken into consideration while issuing appointment orders.

6. If any mistake is noticed regarding names of the candidates against Roll no. or vice versa, the same may be corrected under intimation to this office immediately.

7. Action may kindly be taken for In-house Training and appointment of the qualified candidates after observing vigilance clearance and observing all prescribed formalities in the matter.
