Subject: Introduction of a system for earmarking vacancies on a rotation basis for various categories as provided in the MTS Recruitment Rules in the light of Hon'ble CAT order in OA No. 559/2018 filed by Smt. Rathnavathi.

Sir.

I am directed to refer to Karnataka Circle's letter number LC/2-92/2018 dated 06.01.2020 and 21.10.2019 on the subject cited above.

- 2. Present Recruitment Rules (RRs) for the post of Multi Tasking Staff (MTS) have following enabling provisions for recruitment of Gramin Dak Sevak (GDS) and Casual Labourer to the post of MTS:-
- a) 50% on the basis of seniority cum fitness from amongst Gramin Dak Sevaks of the recruiting Division who have worked regularly for five years in that capacity, as on 1st day of January of the year to which the vacancy(ies) belong to.
- b) 25% on the basis of competitive examination limited to GDS who have worked regularly for three years in that capacity, as on 1st day of January of the year to which the vacancy(ies) belong to.
- c) 25% by appointment of Casual Labourers on the basis of seniority cum fitness.
- 3. Due to non-availability of sufficient number of vacancies every year, it has been suggested by the Circle to introduce a system for earmarking vacancies as provided in the RRs of MTS so that all feeder categories (GDS and Casual Labourers) are given uniform treatment on rotation basis.
- 4. As brought out in para 2 above, vacancies are to be filled up in the ratio of 2:1:1 as follows:

- 5. As informed by the Circle, in most of the recruitment years there is only one or two vacancy (ies), which is/are being filled up from GDS depriving the Casual Labourer from getting appointed to the post of MTS. To ensure equality of opportunity for all the methods of recruitment provided in RRs, the following procedure shall be adopted if there are less than 4 vacancies or vacancies are not in multiples of 4:
 - a. In case there is only one vacancy for the post of MTS in a particular recruiting year, the vacancy will be filled by GDS on the basis of seniority cum-fitness.
 - b. In case there are two vacancies in the next recruiting year, first vacancy will be filled up by GDS on the basis of seniority cum-fitness and second vacancy will be filled up by GDS on the basis of competitive examination.
 - c. In the next recruitment year, the first vacancy will be filled up by Casual labourer on the basis of seniority cum fitness.
 - d. For subsequent vacancy (ies), the above cycle will be repeated.

2nd Casual Labourer cannot be appointed as MTS since there is no 8th vacancy. However, this cycle shall be carried over to the next recruitment year and the first vacancy of the next recruitment year shall be filled up by Casual Labourer through seniority cum fitness. Accordingly, the roster for the next recruitment year 2020 (say there are 14 vacancies) will be as follows:
