Examination for recruitment to the post of MTS from eligible GDS candidates against the vacancy year 2019 & 2020 was held on 11.10.2020.

The seniority will be determined in accordance with the principles laid down in the Dte's communication No. 27-24/65-NCC dated 07.04.1966 in respect of candidates who have secured equal marks in the above Examination.

The selected SC/CT/OBC candidates should be asked to produce the original caste certificates for detailed scrutiny by the Head of the Division to see that (i) It is issued by the appropriate authority and in prescribed form. (ii) That it is genuine & complete in all respects.

If any discrepancy is noticed in the result or if it is found that the candidate was not eligible to appear in the examination, the candidature of the candidate should be cancelled before appointment/Posting. So, the divisional Heads should make scrutiny of the result of the candidate before appointment. Further, if any mistake is noticed regarding the names of the candidates against their Roll No. or vice-versa the same may be corrected under intimation to CO.
