The Head of the Parent Division to ensure obtaining written acceptance / refusal (in enclosed proforma) from the selected candidates adhering the time limit mentioned above and to communicate to the allocated Division.

6. The Divisional Heads are requested to issue provisional appointment orders on or before **09.11.2022** positively, only to the allotted candidates who accepted to join in the promoted/recruited post.


7. Parent Division/Unit head will send the original written refusal letters of candidates duly attested by them to this office on or before **04.11.2022**.
