The notification for Limited Departmental Competitive Examination (LDCE) / Competitive Examination (CE) for promotion/recruitment to the post of Postal Assistant (CO and RO), Postal Assistant (Post Office) and Sorting Assistant (RMS) from eligible officials of Category 'A', Category 'B' and GDSs for the vacancy year 2023(01.01.2023 to 31.12.2023) was issued vide this office memo no. Rectt/X-13/LGO Exam/2023 dated 23.01.2023. The result was declared vide this office memo of even no. dated 11.05.2023. Now, the Competent Authority is pleased to declare the 1<sup>st</sup> Supplementary results of the said LDCE/CE held on 12.03.2023 & DEST held on 07.05.2023 to fill up the vacancies arisen due to declination of promotion of the selected candidates.

2. The result & allotment of candidates of Category 'A' and Category 'B' is annexed as **Annexure-I**.

3. The information relating to names of the candidates, their roll numbers and categories have been shown on the basis of information furnished by the Regions/Divisions/Units. In case there are any mistakes in the details of candidates, the same may be intimated to this office for necessary action. In case, if it is found subsequently that any of the promoted/selected candidates was not eligible to take the examination under the existing rules/instructions on the subject or for any other reasons or in case any mistake is found with regard to announcement of results of any candidate for any reason whatsoever his/her name will be deleted from the list of successful candidates, as the case may be. This result is also subject to any change in the merit list of successful candidates due to any unforeseen reason in accordance with the existing rules and instructions on the subject or orders of Hon'ble CAT/High Court, if any.

4. Results of candidates claiming ST status may be thoroughly verified and any discrepancy noticed may be intimated to Circle Office. The selection & appointment of the candidate belonging to ST is subject to verification of their caste status by the Divisions concerned as per extant instructions on the subject.

5. Before relieving an official to join higher post on promotion and giving appointment to the promoted post, authority concerned shall check to ensure that the official is not falling under any one or more categories mentioned at (a) to (c) of para 3(i) of Directorate's letter no. X-7/6/2022-SPN-II dated 17.05.2023.

6. It may be ensured that no provisional candidate is given appointment without regularization of their candidature. The Regions/Divisions are requested to verify the current status of the candidature of the qualified candidates before appointing the candidate. The candidate against whom vigilance or disciplinary case is pending/ those undergoing punishment should not be appointed and such cases should be referred back to Circle Office.

7. The selection of the candidates is purely provisional subject to the fulfillment of required conditions of relevant Recruitment Rules & verification of genuineness of various mandatory certificates of the candidates by the concerned Head of the Divisions/Units.

8. The appointing authorities are requested to carry out all the required pre-appointment formalities as per relevant rules & instructions issued time to time.

9. The result has been prepared strictly as per merit and candidates have been allotted divisions according to their merit and options of divisions exercised by them.


10. Concerned divisional heads/units head will issue promotion order/offer of appointment only after checking that no vigilance/disciplinary case pending against the candidate. Promotion order /offer of appointment may be issued within 7 days **except SI no.3 & 4**. Candidates who are not willing should submit the unwillingness within 7 (seven) days from issue of the promotion order / offer of appointment in the attached proforma given in **Annexure-II**. If any candidate will not join within 7 (seven) days from the date of issue of this promotion order / offer of appointment, his candidature will automatically be cancelled.

11. Parent Division/Unit head will send the original written refusal letters, if any, of the candidates duly attested by them to concerned Regional office on or before **23.06.2023**. Regional office will send all the original written refusal letters received from Divisions in one lot to this office on or before **27.06.2023**.

12. The contents of this memo may be brought to the notice of all concerned.
