1. That the seniority of the official on joining new Unit will be determined in accordance with provision of revised Rule-38 of P&T Man. Vol. IV.
2. That he/she will not claim any TA/TP.
3. That he/she will not claim for repatriation to his/her parent unit within the prescribed time limit.
4. That the option exercised once by the official is final.
5. That he/she will not claim for repatriation to his/ her parent unit/transfer to any other unit until he/ she complete 5 years in the unit to which transfer is presently sought for.
6. Before giving effect to the transfer order, a written declaration agreeing to the conditions of transfer detailed above should be obtained from the official and kept in his/ her service book. Moreover, if any disciplinary/vigilance case is pending or punishment is current against the official, he/ she should not be relieved and detailed report in the matter should be submitted to C.O.
