Sub: Allotment of Surplus Qualified candidates in respect of Postman / Mailguard Exam, 2017-18, held on 29.10.2017.

I am directed by the competent authority to convey the allotment lists of Surplus Qualified candidates against remaining unfilled vacancies of Postman in respect of different Divisions / Units in Postman / Mailguard Exam held on 29.10.2017 to fill up 50% vacancies of Postman from GDS as per Postman Recruitment Rules, 2010. Remaining unfilled vacancies of Postman / Mailguard cadre to be filled up from MTS cadre could not be filled up due to non availability of Surplus Qualified Candidates.

2. The names of the candidates have been arranged in order of merit from Surplus Qualified candidates and according to number of unfilled vacancies available in Divisions/Units for the year 2017-18. The seniority will be determined in accordance with the principles laid down in the Dte. Comn. No.27-24/65-NCC dated 7-4-66 in respect of candidates who have secured equal marks in the above examination.
3. The selected SC/ST/OBC/PH candidates should be asked to produce the original Caste/Disability Certificate for detailed scrutiny by the Head of Divisions/Units to see that (i) it is issued by the appropriate authority and in prescribed form (ii) that it is genuine and complete in all respect.

4. If any discrepancy is noticed in the result or if it is found that the candidate was not eligible to appear in the examination, the candidature of the candidates should be cancelled before appointment/Posting. So, the Division/Unit Heads should make scrutiny of the result of the candidate before appointment. Further, if any mistake is noticed regarding the names of the candidates against their Roll Number or vice-versa the same may be corrected under intimation to the ADPS (Rectt), C.O. by name.
