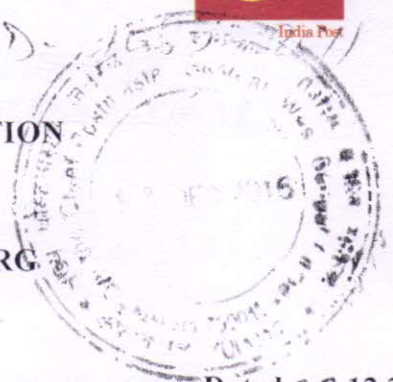

Subject:- Grievances of pensioners regarding disbursement of pension and timely payment of Dearness Relief.

I am directed to refer to above cited subject and intimate that representatives of All India BSNL DOT Telecom Pensioners' Association during the meeting with the Secretary (Posts) have raised the matter of non disbursement of pension by Post Offices in cash. It has been brought to the notice of the Directorate that the pensioners are being asked to deposit their pension in SB accounts and they are further directed to come after 5-7 days and enquire whether cash is available or not.

It was also represented by the Association that increased Dearness Relief is not being included in the pension in due time and payment of arrear of the same is also delayed by the Post Offices.

It is requested that necessary action may be caused to address the issues raised by the Telecom Pensioners' Associations and suitable mechanism be devised for settlement of the grievances of the pensioners.
