2. Vigilance / Disciplinary Case if any

In case any vig./disc. case of the type referred to in DOP&T No.22011/4/91-Estt(A) dated 14.9.92 from DOP&T circulated vide Dte Memo No.25-19/88-SPG dated 13.10.92 is pending against the officer, he should not be relieved for posting without obtaining specific orders from the Directorate. The officer against whom any punishment is current except censure and recovery should not be promoted before expiry of currency of punishment. A report in this regard should be submitted immediately.

3. Fixation of pay.

In case the officer wishes to choose the date for fixation of pay under FR-22(1)(a)(1) he can do so within one month from the date of assumption of charge.

4. The officer in the above list shall be relieved immediately with the direction to join his place of posting on promotion without any delay and his charge report may be sent to the Directorate in due course.

5. If the officer does not join within one month from the date of issue of posting orders, it will be presumed that he/she has declined the promotion and this should be brought to the notice of this office immediately.

6. No representation regarding re-allotment from the officer will be entertained in any case unless he joins the promotional post.
