


Subject:- Regarding timely payment of pension to Telecom pensioners by POs/ CPPCs -reg.

It has been observed that there is a considerable delay in payments of pension, revised pension, Dearness Relief (DR) etc by the Public Sector Banks & Post Offices authorized by the Department of Telecom for disbursing Telecom pension. These facts have also been highlighted by pensioners' association.

In this regard, kindly refer to Para 6.10 A of MOU on Single window system arrived at between Department of Telecommunications and Public Sector Banks as intimated vide letter No. 6-16/2002/TA-I/Vol.III dated 09.10.2012 and amendments issued from time to time, prescribing the time schedule for making such payments for disbursement of pension. Similar action for timely disbursement of Telecom pension is also to be adhered by Post Offices.

It may therefore be ensured at the level of Pr. CCA/CCA that the disbursement of pension, revised pension, DR etc be made by the PS Banks & POs within the prescribed time schedule. The Pr. CCA/CCA may take up any matter involving delay in the monthly/quarterly meeting to be held with Public Sector Banks/Post Offices. The action taken report in this regard be submitted along with SWR monthly. In case of no such delay, a NIL report be furnished.

This issues with the approval of the competent authority.
