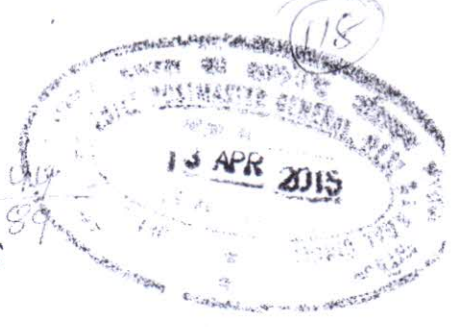


**Sub.: Capturing of Aadhaar card number of the pensioners - regarding.**

This is regarding simplification of procedure for securing annual "Life Certificate" for the purpose of disbursement of Pension to all Pensioners by using digital medium. For this purpose, the Department of Electronics & IT, Ministry of Communications & IT, Government of India has developed "Jeevan Pramaan-Digital Life Certificate" Portal. Hence, it has been decided that Aadhaar card numbers have to be captured in respect of all the employers/employees of all the Departments in the Pay Roll. In this regard, letter no. 26-41/2014-PA (PEA)/D-2183-2322 dated 31.11.2014 (copy enclosed) issued by the undersigned may kindly be referred to. Likewise, it is mandatory for capturing Aadhaar card no in all the PPOs of all kind of Pensioners.

2. Please find enclosed with a copy of letter no. 28-10/TA-I/1332 dated 25.02.2015 received from Department of Telecommunications on the above cited subject. Necessary action may kindly be taken that the Aadhaar number in respect of the Telecom pensions which are being paid by the Post Offices may be captured by the respective Post Offices for further processing. Details of Aadhaar number so captured from all Telecom Pensioners be forwarded to the concerned CCA offices for further updation of records at their end.

3. In addition to the above, Aadhaar number captured in respect of Pensions of Ministries i.e. Railway/Defence etc may also be forwarded to the concerned Ministries/Departments for further updation of records at their end.

4. Hence, it is requested that necessary instructions to all the concerned may be given so that the Aadhaar card numbers of all the Pensioners can be captured.



Subject:- Capturing of Aadhaar card number of the pensioners –reg.

Reference:- The Director (Accounts), DOP, PA Wing, letter no. 12-12/2014-Comp/D-1575/1577 dated 03.02.2015.

With reference to the Director (Accounts) letter under reference on the subject cited above under which necessary arrangement was required to be made by DOT for capturing Aadhaar numbers in respect of Telecom pensioners drawing pension from Post Offices. In this regard, instructions for providing Aadhaar number by the retiring employees in Form 5 and noting the same in the PPOs have already been issued and the same are being implemented by all DOT offices for the new pensioners. For the existing telecom pensioners drawing pension through Post Offices, postal authorities have to capture their Aadhaar numbers as Pension Disbursing Agency (PDA) since the pensioners are directly connected to Post Offices only. The Public Sector Banks have already undertaken this job as PDAs. The DOT as per letter no. 28-10/TA-I/2014/104 to 183 dated 12.01.2015 & CPAO as per its **Correction Slip-22**, has provisioned that a life certificate issued online by a Government Agency as a result of Aadhaar Biometric Authentication will also be accepted as a VALID CERTIFICATE by the Pension Disbursing Agency.

Therefore, it is requested that Aadhaar number in respect of the Telecom pensioners being paid by the Post Offices may be captured by the respective Post Offices for further processing. Details of Aadhaar numbers so captured from all Telecom pensioners be forwarded to all CCA offices for further updation of records.
