Subject: Cadre Restructuring of Group "C" employee in Department of Posts

In continuation of this office letter of even number dated 31.01.2019 on the subject mentioned above, the following order of the Competent authority is hereby accorded for addition and alteration of following posts upgraded vide this office letter dated 31.01.2019 :

1. Total HSG-I post of Central Kolkata Division excluding 1 HSG-I (IP line) will be 21 instead of 22. SPM post (HSG-I IP line) at SI No 8 of Annexure 4A will be kept out of this Cadre Restructuring. Accordingly the sanctioned strength in PA cadre will increased by 1 (One) post.

However the total post of the Division will remain the same as mentioned at Colum "H" & "K" of SI No 4 of Annexure -I.

2. One Existing LSG post (Speed delivery Morning) of Kolkata GPO is hereby upgraded to HSG-I and One PA posts (DA-4, Rectt & Promotion) is hereby upgraded to LSG Posts apart from earlier upgraded Posts.

Hence the total HSG-I post of GPO will be 16 instead of 15 posts and the sanction post of LSG will remain the same due to upgradation of one PA post (DA-4, Rectt & Promotion) to LSG. cadre

Accordingly sanctioned strength of PA cadre will decreased by 1 post whereas HSG-I post will increased by 1 post in r/o Kolkata GPO.

Total Gr C post of the Kolkata GPO will remain the same as mentioned at Colum "H" & "K" of SI No 14 of Annexure -I.
