4. Vigilance/Disc case if any


In case of any vigilance/Disc. Case of the type referred to in OM No.22011/2//86-estt.(A) dated 12.01.88 from DOP&T circulated vide memo no. 25-19/88-SPG dated 04.05.88(subsequently) revised vide DOP&T memo no. 22022/4/91-Estt(A) dated 14.09.92 circulated vide Dte Memo no. 25-19/88-SPG dated 13.10.92 is pending against any official(s) he/she should not be relieved for posting without obtaining specific orders from Circle Office. The official(s) against whom any punishment is current except censure and recovery of money they should not be promoted before expiry of currency of punishment. A report in this regard may be submitted immediately.

5. Fixation of Pay

The official who is to give option for choosing date for fixation of pay under FR-22(1)(a)(1) should do so within one month from the promotion.


