
The above transfer is subject to the following conditions that :-

4. That he/she will not claim repatriation to his parent unit.
5. Before giving effect to the transfer order, a written declaration agreeing to the conditions of transfer detailed above, should be obtained from the official and kept in his/her Service Book. Moreover, if any disciplinary/vigilance case is pending or punishment is current against the official, he/she should not be relieved and detailed report in this matter should be submitted to this office.
6. The relieving unit is requested to see that no such official to be transferred on this memo is actually relieved before the posting order in respect of concerned official is received by him.

Before giving effect to the transfer orders, written declarations agreeing to the conditions of transfer detailed above should be obtained from the official and kept in his Service Book.

It is further intimated that the cases of transfer of remaining officials may be processed and considered in the next year according to the vacancy and accommodation.






