2. If the officials so promoted in LSG(SBCO) cadre on regular basis have already been awarded financial up-gradation under TBOP/BCR/MACP-I/II/III, they will continue to draw the existing grade pay in the respective pay band. No benefit of pay fixation shall accrue for such promotion in LSG Cadre.



4. In case any loss/fraud/vigilance/disciplinary/criminal case is pending or punishment is current against any of the above officials, he /she should not be promoted without obtaining specific orders from the Circle Office.


