Whereas 29(twenty nine) erstwhile LDCs, Now PACO officials in CO/RO was granted antedating TBOP promotion with reference to their junior officials vide CO memo no. SFA/P-32/ TBOP/ BCR/ Modification/99 dated 13.07.99 considering the then seniority list of officials working in CO/RO and in pursuance of Dte's Communication no. 4-12/88-PE-I (Pt) dated 22.07.1993 regarding introduction of TBOP/BCR scheme, followed by Dte's Clarificatory orders no. 22-5/95-PE-I dated 08.02.96, 26.03.96 and No. 44-60/96-SPB-II dated 24.09.96 in connection with modification of TBOP/BCR scheme.

Whereas the seniority list of PACO officials so prepared is found irregular and erroneous one in view of the DoPT guidelines issued time to time. On administrative approval, the seniority list of PACO officials corrected upto 01.07.2016 has been revised after necessary correction through a committee formed in this connection and revised seniority of PACO officials corrected upto 01.07.16 has been published vide CO memo no. SFA/P-32/TBOP/BCR/2018 dated 15.02.2022.

Now, the cases of antedating promotion of 29(twenty nine) erstwhile LDCs, now PACO officials in CO/RO granted antedating TBOP promotion vide ibid memo dated 13.07.1999 have been reviewed through Departmental Promotion Committee on the basis of revised seniority list of PACO officials corrected upto 01.07.2016 circulated under ibid memo no. 15.02.2022 and in the light of Dte's guidelines regarding modification of TBOP/BCR scheme mentioned above. 14(fourteen) PACO officials out of 29 erstwhile LDCs, now PACO in CO/RO granted antedating TBOP financial up-gradation vide ibid memo dated 13.07.1999 have been found junior to Smt. Bharati Ghosh as per revised seniority list of PACO officials corrected upto 01.07.2016. Such 14 officials have been considered and recommended by the review DPC and approved by the competent authority for their promotion/financial up-gradation under TBOP scheme in the scale of 4500/-7000/- (pre-revised) from the scale of pay of Rs. 4000/- -6000/- (pre-revised) with effect from the date mentioned below against their name.


