In pursuance of Dte.'s letter no. 25-04/2012-P.E.I dated 27-05-2016, the following HSG-I officials who have been approved for non-functional upgradation to HSG-I (NFG) grade by the DPC held on 08-07-2021 are now granted HSG-I (NFG) grade in Postal Unit in the pay band of Rs 9,300-34,800/- (PB-2) with Grade Pay Rs. 4,800 /- & pay matrix level 8 from HSG-I cadre in the pay band of Rs 9,300 – 34,800 /- (PB-2) with Grade Pay Rs. 4,600 /- & pay matrix level 7 with effect from the dates they actually assume the charge of the allotted post.

2. Following orders regarding allotment in the cadre of HSG-I (NFG) in Postal Unit to the Regions as mentioned against each are issued to have immediate effect.

3. Posting order of the officials allotted to the Regions should be issued by the Regions concerned immediately against the post identified for the same vide CO Memo No. Est/B/Z-197/2016 dated 09-11-2020 and 21-02-2022 and CO Memo No. Est/B/Z-197/Corr dated 09-04-2021.

4. Vigilance/Disc case, if any

In case of any vigilance/disc. case of the type referred to in OM No.22011/2/86-estt.(A) dated 12.01.88 from DOP&T circulated vide memo no. 25-19/88-SPG dated 04.05.88(subsequently) revised vide DOP&T memo no. 22022/4/91-Estt(A) dated 14.09.92 circulated vide Dte Memo no. 25-19/88-SPG dated 13.10.92 is pending against any official(s) he/she should not be relieved for posting without obtaining specific orders from Circle Office. The official(s) against whom any punishment is current except censure and recovery of money they should not be promoted before expiry of currency of punishment. A report in this regard may be submitted immediately.

5. Fixation of Pay

The official who is to give option for choosing date for fixation of pay under FR-22(1)(a)(1) should do so within one month from the promotion.


6. The Regions are requested to intimate the date of joining of the officials in the post of HSG-I (NFG) in a consolidated manner invariably within 30 days from the date of issue of this order for preparation of Gradation List of HSG-I and HSG-I (NFG) cadre officials.

7. As per norms stipulated in OM No. 4-7/MACPS/2019-PCC dated 30-10-2019 circulated vide CO memo no. Est/B/Z-7th CPC (MACPS)/2016 dated 30-10-2019, if any official declined the regular promotion before becoming entitled to an upgradation under MACPS, no financial upgradation under MACPS shall be allowed as such the employee has not stagnated due to lack of opportunities. If, however, financial upgradation under MACPS has been allowed due to stagnation and the employees subsequently refuse the promotion, it shall not be a ground to withdraw the financial upgradation. The official, however, will not be eligible to be considered for further financial upgradation till he agrees to be considered for promotion again and in such case the second or next financial upgradation shall also be deferred to the extent period of debarment due the refusal of promotion.
