In pursuance of Postal Directorate, New Delhi instruction communicated vide letter No: X-20/7/2018-SPN-II dated 12-04-2019 followed by clarification of even number dated 22-11-2019, the approval of Chief Postmaster General, West Bengal Circle is hereby conveyed for merger of non-technical posts in Level 1 to Level 7 in PSD, Kolkata with the corresponding posts in Central Kolkata Postal Division (Postal Division which is covering the geographical area of PSD, Kolkata). The merger is subject to the following conditions:-

- i. The Sanctioned strength of the non-technical posts (Level 1 to Level 7) of PSD Kolkata to be added to the sanctioned strength of corresponding posts of Central Kolkata Division. The non-technical posts include Inspector of Posts, HSG-I, HSG-II, Stenographer Grade II, LSG, PA & MTS Group C.
- ii. The gradation list of Central Kolkata Division shall also include the non-technical posts of PSD, Kolkata.
- iii. Central Kolkata Division shall be the feeder Division for recruiting/posting of officials in PSD, Kolkata on tenure basis.
- iv. The transfer/posting of existing officials of PSD, Kolkata will be controlled by the Central Kolkata Division and such transfer/posting can be made in/out of PSD Kolkata as the transfer/posting is purely tenure basis. Therefore, officials working in Central Kolkata Division are also eligible for transfer/posting in PSD, Kolkata on tenure basis.
- v. No separate vacancies will be maintained for PSD, Kolkata for posts in Level 1 to Level 7 after the merger. Vacancy of these non-technical posts will be maintained by Central Kolkata Division.
- vi. The reporting Officer in respect of APAR and leave sanctioning authority in respect of IPs/HSG-I/HSG-II officials of PSD, Kolkata will be Supdt., PSD, Kolkata.
- vii. The Supdt. PSD, Kolkata will continue to exercise the statutory power in connection with disciplinary proceedings in respect of the existing officials of PSD, Kolkata as per provision of Rule 11 (i) to (iv) of CCS (CCA) Rules 1965

and SSPOs, Central Kolkata Division will act as Disciplinary authority as per provision of Rule -12 of CCS (CCA) Rules 1965.

viii. The Head of Circle will be the controlling authority of PSD, Kolkata.

The Central Kolkata Division will take necessary action in this regard and submit action taken report duly approved by the Regional Head Concerned.
