In pursuance to instructions contained in Directorate letter no. 17-08/2018-SPN-I dated 15.06.2022, selection of GDS candidates through Competitive Examination has been done by preparing a single merit list at Circle Level. The selected candidates have been allotted to the parent divisions/units as per merit (Marks obtained in Paper-I) with community concerned vis-a-vis the availability of vacancies in the parent division/unit by following the relevant Recruitment Rules of MTS, 2018 issued by Dte's letter no. 37-33/2009-SPB-1 dated 27.08.2018.
- 3. The list of 74 qualified GDS candidates with the allocation of their Parent Unit for the post of MTS is annexed as **Annexure-I**.
- 4. The information relating to names of the candidates, their roll numbers and categories have been shown on the basis of information furnished by the Regions/Divisions/Units. In case, if it is found subsequently that any of the recruited GDS candidates was not eligible to take the examination under the existing rules/instructions on the subject or for any other reasons or in case any mistake is found with regard to announcement of results of any candidate for any reason whatsoever his/her name will be deleted from the list of successful candidates, as the case may be. This result is also subject to any change in the merit list of successful candidates due to any unforeseen reason in accordance with the existing rules and instructions on the subject or orders of Hon'ble CAT High Court, if any.
- 5. Results of candidates claiming SC/ST status may be thoroughly verified and any discrepancy noticed may be intimated to Circle Office. The selection & appointment of the candidate belonging to SC/ST is subject to verification of their caste status by the Divisions concerned as per extant instructions on the subject.
- 6. It may be ensured that no provisional candidate is given appointment without regularization of their candidature. The Regions/ Divisions are requested to verify the current status of the candidature of the qualified candidates before appointing the candidate. The candidate against whom vigilance or disciplinary case is pending/ those undergoing punishment should not be appointed and such cases should be referred back to Circle Office.
- 7 The selection of the candidates is purely provisional subject to the fulfillment of required conditions of relevant Recruitment Rules & verification of genuineness of various mandatory certificates of the candidates by the Head of the Divisions Units.

- 8. The appointing authorities are requested to carry out all the required pre-appointment formalities as per relevant rules & instructions issued time to time.
- 9. The result is prepared as per the guidelines received from Directorate and in accordance with the merit.
- 10. Selected candidates are requested to submit written acceptance/ refusal for joining in MTS Cadre to their parent Division/Unit within three (03) days positively from the date of publication of this result. The Head of the Parent Division to ensure obtaining written acceptance/ refusal from the selected candidates adhering the time limit mentioned above.
- 11. The Divisional Heads are requested to issue promotion orders to the successful candidates on or before 03.02.2023 positively clearly indicating that if the official does not join the promotional post within seven (07) Days it will be deemed to have been refused. Official on leave may be allowed to join even after seven (07) Days if they communicate in writing to accept the promotion and in that case the official will be allowed after expiry of approved leave period. Controlling Officers are advised to contact such successful candidates who are on leave for obtaining their consent to join promotional post in writing. Similarly candidates who do not wish to join promotional posts may be encouraged to communicate the same in writing.
- 12. Parent Division/Unit head will send the original written refusal letters of the candidates duly attested by them to concerned Regional office on or before 13.02.2023. Regional office will send the entire original written refusal letters received from Divisions in one lot to this office on or before 20.02.2023.
