

3. The question paper shall be both in English & Hindi. The candidates have the option to write the answer either in English or Hindi.
4. The format of the application form is enclosed as Annexure 'A' and admit card as Annexure 'B'.
5. The syllabus and pattern of the examination: The examination will be conducted as per revised syllabus circulated under PA Wing, Dak Bhawan letter no 3-09/2022/PACE/DE/3211-3235 dated 03.04.2024 (Copy enclosed as Annexure- C).
6. Eligibility: As per Department of Posts, PA Wing, Recruitment rules notification dated 11th Oct, 2010 notified in GSR 187 read with Director (PA Admn) OM no 01(01)/2024/PA Admn.I/6226-6248 dated 07.10.2024, the following category(ies) of official(s) are eligible to appear in the examination.
 - i) Any 12th Class or equivalent MTS of the W.B.Postal Circle i.e., working in POs, RMS, Civil/Electrical Wings/Circle Offices & Postal Divisional Offices including MTS of PAOs who have rendered not less than two years of regular service in MTS cadre as on 01.01.2024.
 - ii) Any other eligibility conditions specified in Recruitment Rules shall also apply.
7. Qualifying/Pass Marks: As per DG P&T (Postal Accounts) letter no 3(i)-PA(CE)/242 dated 8th Nov, 1976, the minimum qualifying marks for declaring a person successful in the examination is 40% each for Paper-I & Paper-II.

With regard to Paper III i.e., Type test on Computer, the total number of mistakes should not exceed 10%.
8. Mere passing of examinations will not confer any claim upon any one for promotion which will depend on the availability of vacancies and the suitability for promotion from others point of view.
9. The provisional vacancy in LDC cadre in DE quota for MTS who may succeed in this examination is given below.

10. How to apply:

- i) The applicants are required to apply in the prescribed application form enclosed as at Annexure 'A' & Annexure 'B' affixing therein their recent passport size color photograph in the space provided for. Blank application form may be printed on A-4 size white paper.
- ii) Mere issuing of admit cards to the applicants will not imply that his/her candidature has been finally accepted. Their candidatures at all the stages of the examination will be purely provisional subject to the satisfying the prescribe eligibility conditions.
- iii) The Heads of Divisions/Units will compile a list of applicants from whom he/she has received filled in application forms i.e. Annexure 'A' & Annexure 'B' duly verified and

attested by them and forward a list as in Annexure D along-with the application forms to this office as detailed in Annexure E.


- iv) The admit cards will be dispatched by post to the respective Divisional Head/Unit Head.
11. Centre of Examination - The center of examination will be decided by the Competent Authority in due course and the venue of the examination will be intimated accordingly.
 12. The application of the APS candidates should be sent to the concerned divisions/unit head and not to this office directly.
 13. The guidelines issued vide letter no 29-6/2019-DD-III dated 10.08.2022 (as modified time to time) by the Department of Empowerment of Persons with disabilities (Divyanjan) regarding grant of scribe and compensatory time to eligible disabled persons shall be followed in letter and spirit.
 14. All instructions issued by Directorate vide letter no X-7/6/2022-SPN-II dated 17.05.2023 as amended vide letter no X-7/6/2022-SPN-II dated 22.09.2023 and 04.03.2024 regarding promotion of Government servants through LDCE against whom disciplinary/criminal prosecution are pending will be followed scrupulously.
 15. The Competent Authority reserves the right to cancel this notification or change or modify in the schedule, pattern and syllabus of the examination partially or completely at any point of time.
 16. TA/DA is not admissible to any applicant for appearing in the examination.
 17. The candidates who are willing to apply for the examination should ensure that they fulfill/satisfy all the eligibility criteria/conditions/instructions mentioned above for appearing in the examination.
 18. This notification may be given wide publicity amongst all eligible candidates working in Circle Office/Divisions/Units.


