With reference to the notification for CE issued vide No. Rectt./X-16/CE/PM-MG & MTS/2025 dated 16.07.2025 and the result of Competitive Examination (CE) for recruitment to the post of MTS from eligible GDS candidates for the vacancy year 2025 (01.01.2025 to 31.12.2025) held on 31.08.2025, declared vide this office memo. No. Rectt./X-16/PM-MG & MTS/2025/AD (R)/Part-I dated 05.12.2025, the competent authority is pleased to declare the supplementary result of the Competitive Examination (CE) for recruitment to the post of MTS from eligible GDS candidates for the vacancy year 2025 (01.01.2025 to 31.12.2025) held on 31.08.2025.

2. The selection of GDS candidates through CE to MTS have been done by preparing single merit list at Circle level. The selected candidates have been allotted to the Divisions/Units as per their merit position (according to total marks obtained in Paper-I) and on the basis of their Option for Order of preference viz-a-viz the availability of vacancies in the Divisions in respective categories.

3. The list of 31 (thirty one) qualified GDS candidates selected against MTS posts with the allocation of Division/Unit are enclosed as per **Annexure-A**.

**Note:** Further, 5 posts of MTS have been kept vacant in compliance of the interim order of the Hon'ble CAT, Kolkata Bench in OA No. 1711/2025.

4. The information relating to particulars of the candidates, viz., name of the candidates, their roll numbers, category, Date of Birth, Date of engagement etc. have been shown on the basis of information furnished by the Regions/Divisions/Units and confirmations furnished subsequently. If it is found subsequently that any of the selected GDS candidate was not eligible to take the examination under the existing rules/instructions on the subject or for any other reasons or in case any discrepancy is found with regard to announcement of results of any candidate for any reason whatsoever, his/her name will be deleted from the list of successful candidates, as the case may be. This result is also subject to any change in the merit list of successful candidates due to any unforeseen reason in accordance with the existing rules and instructions on the subject or on orders of Hon'ble CAT/High Court, if any including the final outcome of the OA No. 1711/2025.

5. Before issuing appointment letter to the candidates, **category of the candidates concerned claiming SC/ST/OBC/EWS/PwBD relaxation, must be thoroughly verified in accordance with the existing rules and instructions on the subject or orders of Hon'ble CAT/High Court/Supreme Court passed, if any.**

5.1. **Selection of all the candidates against reserved vacancies of PwBD will be purely provisional subject to verification/confirmation of the permanent disability before joining to MTS Cadre as per the guidelines contained in the order of the Department of Empowerment of Persons with Disabilities (Divyangjan) OM No. P-13013/57/2023-Policy dated 20.01.2024 circulated vide Postal Directorate F. No. SC-12/3/2024-SCT-DOP dated 13.03.2025.**

5.2. **Selection of all the candidates selected against reserved vacancies of OBC will be purely provisional subject to verification/confirmation of the OBC certificates under OBC category belonging to Non-Creamy Layer as per extant rules in force before joining in the MTS Cadre.**

6. **The selection and appointment of the candidates belonging to SC/ST/OBC/EWS/PwBD is subject to verification of their caste/ status by the Division/Unit concerned in accordance with the existing rules and instructions on the subject or on orders of Hon'ble CAT/High Court/Supreme Court, if any, passed from time to time.**

7. It may be ensured that no provisional candidate is given appointment without regularization of their candidature. The Regions/Divisions are requested to verify the current status of the candidature of the qualified candidates before appointing the candidates. The candidate against whom vigilance or disciplinary case is pending/those undergoing specified punishment should not be appointed and such cases should be referred back to the Circle Office as per extant of guidelines issued by the Postal Directorate from time to time.
8. The selection of the candidates is purely provisional subject to fulfilment of required conditions of relevant Recruitment Rules and verification of genuineness of various mandatory certificates of the candidates by the concerned Head of the Divisions/Units.
9. The appointing authorities are required to carry out all pre-appointment formalities as per relevant rules and instructions issued from time to time.
10. Selected candidates are requested to submit written acceptance / refusal for joining in MTS cadre to their parent Division/Unit **within three (03) days positively** from the date of publication of this result. The Head of the parent Division/Unit must ensure obtaining written acceptance/refusal from the selected candidates adhering the time limit mentioned above.
11. **The Divisional/Unit Heads are requested to issue appointment orders to the successful and confirmed candidates on or before 06.05.2026 positively clearly indicating that if the candidate does not join the recruited post within seven (07) days it will be deemed to have been refused as per Para C (Stage-II) w.r.t. Para G (Stage-VI (List of GDS candidates for the post of MTS)) to Postal Directorate letter No. 17-08/2018-SPN-I dated 18.10.2023. Official on leave may be allowed to join even after seven (07) days if they communicate in writing to accept the appointment and in that case the official will be allowed after expiry of approved leave period.** Controlling officers are advised to contact such successful candidates who are on leave for obtaining their consent to join recruited post in writing. Similarly, candidates who do not wish to join recruited post may be encouraged to communicate the same in writing.
12. Parent Division/Unit head will send the original written refusal letters of candidates duly attested by them to concerned Regional Office (Circle Office for the HQ Region) on or before **12.05.2026**. Region Offices will send the entire original written refusal letters received from Divisions in one lot to this office on or before **13.05.2026**.
13. The contents of this memo may be brought to the notice of all concerned.
