With reference to the notification issued vide no. Rectt/X-13/LGO Exam/2025 dated 09.06.2025 & 24.07.2025 and Rectt/X-13/GDS to PA,SA Exam/2025 dated 09.06.2025 & 24.07.2025, notification for DEST issued vide letter no. Rectt/X-13/LGO Exam/2025 dated 12.09.2025 and result declared vide Circle Office Memo. No. Rectt/X-13/LGO Exam/2025 dated 19.09.2025, the Competent Authority is pleased to declare the supplementary results of the Limited Departmental Competitive Examination (LDCE) for promotion to the post of Postal Assistant (CO) and Sorting Assistant (RMS) from eligible officials of Category 'A' for the vacancy year 2025 (01.01.2025 to 31.12.2025) held on 17/08/2025 & DEST held on 17/09/2025.

2. The selection of Postal Assistant (CO) and Sorting Assistant (RMS) candidates through LDCE to PA(CO) and SA(RMS) have been done by preparing a single merit list at Circle Level. The selected candidates have been allotted to the divisions/units as per merit position (according to the marks obtained in Paper-I and subject to qualifying in DEST) and on the basis of their preference of Cadre and Posts viz-à-viz the availability of vacancies in Divisions/Units.

3. The result & allotment of candidates in supplementary result is annexed as per **Annexure-A**.

4. The information relating to particulars of the candidates, viz, name of the candidates, their roll numbers, Date of Birth, Date of joining and community/categories have been shown on the basis of information furnished by the Regions/Divisions/Units. In case of discrepancies, if any, the same may be intimated to this office. If it is found subsequently that any of the selected candidates was not eligible to take the examination under the existing rules/instructions on the subject or for any other reasons or in case any discrepancy is found with regard to announcement of results of any candidate for any reason whatsoever, his/her name will be deleted from the list of successful candidates, as the case may be. This result is also subject to any change in the merit list of successful candidates due to any unforeseen reason in accordance with the existing rules and instructions on the subject or orders of Hon'ble CAT/High Court, if any.

5. Results of candidates claiming SC/ST/PwBD status may be thoroughly verified and any discrepancy noticed may be intimated to Circle Office. The selection & appointment of the candidate belonging to SC/ST is subject to verification of their caste status by the Divisions concerned in accordance to the existing rules and instructions on the subject or on orders of Hon'ble CAT/High Court/Supreme Court passed, if any.

6. The selection and appointment of the candidates belonging to SC/ST is subject to verification of their caste status by the Divisions concerned in accordance to the existing rules and instructions on the subject or on orders of Hon'ble CAT/High Court/Supreme Court passed from time to time.

7. It may be ensured that no provisional candidate is given appointment without regularization of their candidature. The Regions/Divisions are requested to verify the current status of the candidature of the qualified candidates before appointing the candidates. The candidate against whom vigilance or disciplinary case is pending/ those undergoing specified punishment should not be promoted and such cases should be referred back to the Circle Office as per extant guidelines issued by the Postal Directorate from time to time.

8. The selection of the candidates is purely provisional subject to the fulfilment of required conditions of relevant Recruitment Rules & verification of genuineness of various mandatory certificates of the candidates by the concerned Head of the Divisions/Units.

9. The appointing authorities are required to carry out all pre-appointment formalities as per relevant rules & instructions issued time to time.

10. Selected candidates are requested to submit written acceptance/refusal for joining in Postal Assistant (CO) and Sorting Assistant (RMS) cadre to their parent Division/Unit within three (03) days positively from the date of publication of this result. The Head of the parent Division must ensure obtaining written acceptance/refusal from the selected candidates adhering the time limit mentioned above.


11. **The Divisional heads/unit heads are requested to issue promotion orders to the successful candidates on or before 27.05.2026 positively clearly indicating that if the candidates does not join the promotional post within seven (07) days it will be deemed to have been refused. Official on leave may be allowed to join even after seven (07) days if they communicate in writing to accept the promotion and in that case the official will be allowed after expiry of approved leave period. Controlling officers are advised to contact such successful candidates who are on leave for obtaining their consent to join promotional post in writing. Similarly, candidates who do not wish to join promotional posts may be encouraged to communicate the same in writing.**

12. Parent Division/Unit head will send the original written refusal letters of candidates duly attested by them to concerned Regional Office (Circle Office for the HQ Region) on or before **02.06.2026**. Region Offices will send the entire original written refusal letters received from Divisions in one lot to this office on or before **03.06.2026**.

13. The contents of this memo may be brought to the notice of all concerned.
