They may not be posted in any sensitive assignment or where they are required to exercise administrative powers till they are trained by PTCs. It should be ensured that the candidates are not posted in the Divisions in which his/her home town is situated.

3. Vigilance/ disc. case if any :

**In case any vigilance/ disc. case of the type referred to in O.M. No. 22011/4/91-Estt(A) dtd. 14-09-1992 from DOP&T circulated vide Dte. Memo No. 25-19/88-SPG dtd. 13-10-1992 is pending against the official, he/she should not be relieved for posting without obtaining specific orders from this office. The official against whom any punishment except censure & recovery from pay for the pecuniary loss caused to the Govt. due to negligence or breach of orders is current should not be promoted before expiry of currency of punishment.**

4. Options for fixation of pay :

The official who wish to give option for choosing date of fixation of pay under FR-22 (I) (a) (1) should do so within 1 (one) month from the date of assumption of charge.


