4. Vigilance/Disc case, if any

In case of any vigilance/disc. case of the type referred to in OM No.22011/2/86-estt.(A) dated 12.01.88 from DOP&T circulated vide memo no. 25-19/88-SPG dated 04.05.88(subsequently) revised vide DOP&T memo no. 22022/4/91-Estt(A) dated 14.09.92 circulated vide Dte Memo no. 25-19/88-SPG dated 13.10.92 is pending against any official(s) he/she should not be relieved for posting without obtaining specific orders from Circle Office. The official(s) against whom any punishment is current except censure and recovery of money they should not be promoted before expiry of currency of punishment. A report in this regard may be submitted immediately.

5. Fixation of Pay

The officials who are already in receipt of Pay Matrix Level 7 or above will continue to draw the existing Pay Matrix Level in the respective pay band. If any official is yet to draw the Pay Matrix Level 7, he may give option for choosing date of fixation of pay under FR-22(I)(a)(1) within one month after joining in promotional post.

- 6. The Regions/Unit are requested to intimate the date of joining of the officials in the post of HSG-I cadre invariably within 30 days from the date of issue of this order for updation of Gradation List of HSG-I and
- 7. In case the official is not willing to accept promotion his declination letter in writing should be obtained and forwarded to this office within 30 days from the date of issue of posting order. The officials decline promotion will be debarred for further promotion for one year from the date of their declination.

As per norms stipulated in OM No. 4-7/MACPS/2019-PCC dated 30-10-2019 circulated vide CO memo no. Est/B/Z-7<sup>th</sup> CPC (MACPS)/2016 dated 30-10-2019, if any official declined the regular promotion before becoming entitled to an upgradation under MACPS, no financial upgradation under MACPS shall be allowed as such the employee has not stagnated due to lack of opportunities. If however, financial upgradation under MACPS has been allowed due to stagnation and the employees subsequently refuse the promotion, it shall not be a ground to withdraw the financial upgradation. The official, however, will not be eligible to be considered for further financial upgradation till he agrees to be considered for promotion again and in such case the second or next financial upgradation shall also be deferred to the extent period of debarment due the refusal of promotion.

## Part-B

The orders of the Competent Authority regarding inter-Region transfer in the cadre of HSG-I (Postal General Line) are issued to have immediate effect without any TA/TP. If any disciplinary/ vigilance case is pending or punishment is current against any official he/ she should not be relieved to join in his/her new place of posting and a report to that effect should be submitted to this office immediately.
